

RESOLUTION NO. 2274

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF WICKENBURG, MARICOPA AND YAVAPAI COUNTIES, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON AUGUST 4, 2020

WHEREAS, the Town of Wickenburg, Maricopa and Yavapai Counties, Arizona did hold a primary election on August 4, 2020, for the nomination of Mayor and three (3) Council Members; and

WHEREAS, the election returns have been presented to and have been canvassed by the Town Council and attached as Exhibit "A."

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Town of Wickenburg, Maricopa and Yavapai Counties, Arizona, as follows:

SECTION 1. That the total number of ballots cast at said Primary Election, as reported was as follows:

Maricopa County – 2,288 Yavapai County - 447
